



### **\$10K Giveaway Terms and Conditions**

Instructions on how to enter and prizes form part of these terms and conditions.

#### **Section 1: General Information**

2. **Promotion Period:** The Promotion will run between 9:00am on 2 September 2019 to 5.00pm AEST on 31 October 2019.
3. **Eligibility:** To be eligible to enter the draw, entrants must satisfy the following criteria:
  - (a) purchase a new Queensland Country Health Fund health insurance policy during the promotional period, excludes policy changes, upgrades or downgrades;
